# Q4 FY23 EBIDTA at Rs. 11.29 Cr., YoY growth of 24.44%, on account of higher sales

## Q4 FY23 PAT at Rs. 6.27 Cr., YoY growth of 25.46%

**Mumbai,** 27<sup>th</sup> May 2023: Creative Newtech Limited (NSE: CREATIVE), market specialists for experiential products in IT, Imaging, Lifestyle, and Security domains with a pan-India presence, announced its audited Standalone financial results for the fourth quarter and year ended March 31<sup>st</sup>, 2023.

### Performance Highlights for the fourth quarter ended 31st March, 2023:

- **Total Income** for the quarter was **Rs. 397.74 crore** in Q4 FY23, **a YoY increase of 52.71%.** Strong demand for brands such as Samsung, Viewsonic, Cooler Master and Honeywell supported growth
- **EBITDA** was at **Rs. 11.29 crore** in Q4 FY23, **YoY growth of 24.44%**, mainly on the back of higher revenues
- **EBITDA Margin** was **2.84%**, vis-à-vis 3.48% in Q4 FY22. Change in product mix offset the reduction in other expenses, leading to contraction of margins
- PAT was Rs. 6.27 crore in Q4 FY23, YoY increase of 25.46%. Net Profit Margin stood at 1.58%

### Performance Highlights for the year ended March 31st, 2023:

- **Total Income** for the period was **Rs. 1,357.80 crore** in FY23, **a YoY increase of 45.51%.** Strong demand for brands such as Samsung, Cooler Master, Viewsonic and Honeywell supported growth.
- **EBITDA** was at **Rs. 38.62 crore** in FY23, **YoY growth of 26.68%**, primarily due to higher sales. **EBITDA Margin** was **2.84%**, vis-à-vis 3.27% in FY22, due to a change in the product mix.
- **PAT** was **Rs. 20.85 crore** in FY23, **YoY increase of 21.30%**. **Net Profit Margin** stood at 1.54%

### Management Comment:

# Commenting on performance, Mr. Ketan Patel, Chairman & Managing Director of Creative Newtech Ltd. said:

"The last fiscal year witnessed several headwinds in the form of macro-economic volatility and geo-political tensions, impacting the overall markets. However, the shift towards digital technologies continues to drive demand. Our agile business model, selective strategies and niche portfolio helped us navigate this period successfully.

In the quarter ended March 2023, our standalone total income grew 52.71% YoY to Rs. 397.74 cr. EBITDA and PAT increased 24.44% and 25.46% YoY to Rs. 11.29 cr and Rs. 6.27 cr, respectively. This growth was mainly driven by demand for products from brands like Samsung, Honeywell, Cooler Master and View Sonic, among others. A change in the product mix had a bearing on the margins.

We continue to selectively focus on key niche brands where we see scope for growth while leveraging our widespread network. During this period, we added Cricut and Razor to our brand portfolio, both of which are among leading names in their respective fields of craftwork and gaming.


